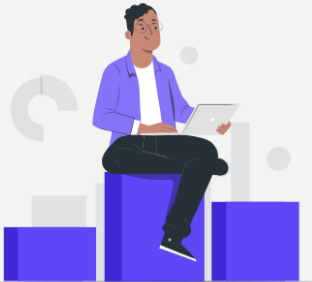

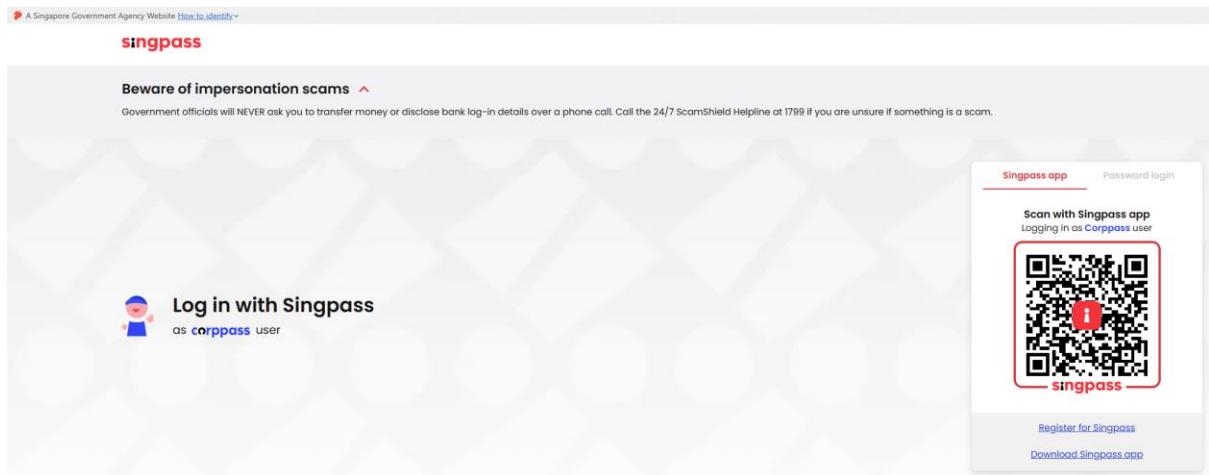

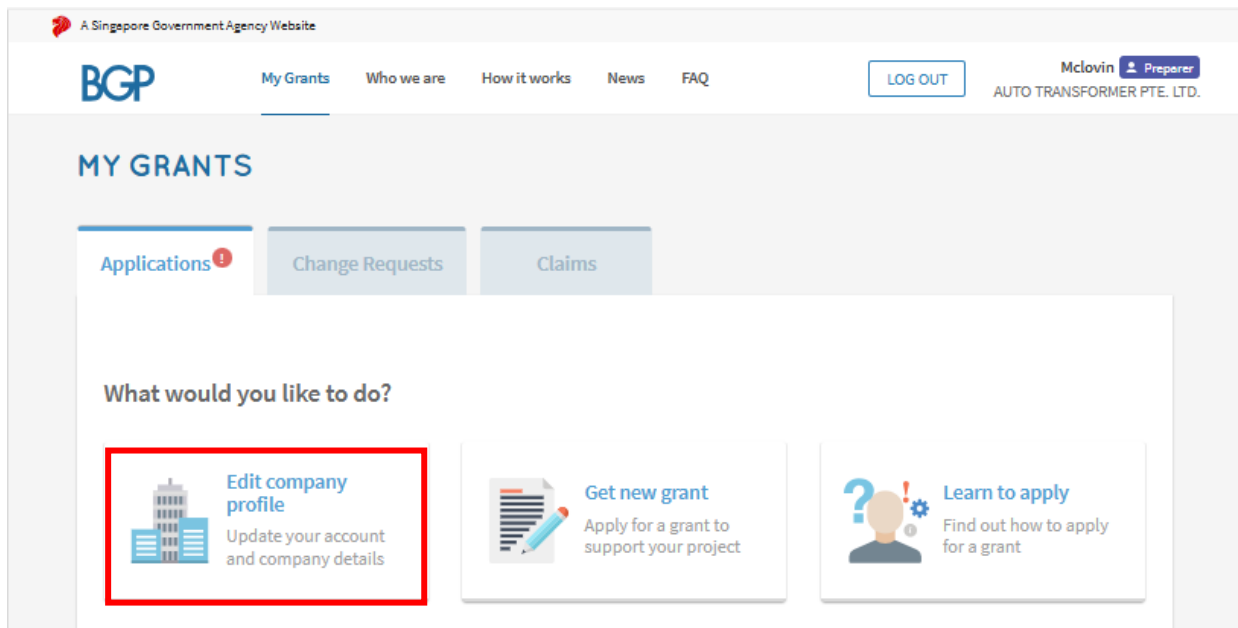

GRANT ACTIONS

[Market Readiness Assistance]

Market Readiness Assistance supports companies entering new markets to embark on overseas market promotion, overseas business development and overseas market set up activities. From 1 April 2023, SMEs can receive up to 50% support for the MRA grant. The enhanced grant cap of up to S\$100,000 will be extended until 31 March 2026.

For projects approved under this grant scheme, the Applicant shall be required to consent to the Comptroller of Goods and Services Tax Act and Comptroller of Income Tax disclosing information relating to the value of the supply of any goods and services, or the income or items of income, of the Company to Enterprise Singapore and other Government agencies (including Ministries and Statutory Boards) (collectively "Agencies"), for the performance of their official duties, and to non-Government persons engaged by Agencies in the performance of any of their official duties.

[Business Adaptation Grant]

Business Adaptation Grant supports Singapore companies to adapt their business operations and strengthen supply chain resilience. From 1 October 2023, Singapore companies can receive support under the Business Adaptation Grant for a time-bound period of 2 years.
