EnterpriseSG, SBF and SSG launch new foundational playbook to help enterprises embark on sustainability

- 1. To support Singapore enterprises in developing new capabilities in sustainability, Enterprise Singapore (EnterpriseSG), Singapore Business Federation (SBF) and SkillsFuture Singapore (SSG) have jointly launched a foundational sustainability playbook titled "Sustainability Playbook for Enterprises: Embarking on your Environmental, Social and Governance (ESG) journey"¹. This was announced today by Minister for Trade and Industry Mr Gan Kim Yong at a visit to marine and offshore company Sea Forrest².
- The playbook provides a step-by-step guide to help enterprises assess their ESG readiness, and a list of relevant resources such as self-help guides and training programmes to help companies get started on this journey. This includes a 3-stage sustainability journey of enterprises.
 - (i) Stage 1: Build awareness in sustainability
 Start by understanding key sustainability concepts, identifying relevant trends, requirements, and opportunities.
 - (ii) Stage 2: Identify relevant areas for intervention
 Establish baselines and potential areas of improvement by engaging stakeholders to identify material areas and collecting relevant data.
 - (iii) Stage 3: Embark on projects to improve and meet targets
 Set targets and determine concrete steps to improve sustainability performance and meet targets. Implement and review initiatives.

- 3. The playbook complements other sustainability playbooks that have been launched or are currently being developed by EnterpriseSG and our partners. These playbooks are a foundational tool that enterprises can tap to increase their understanding of sustainability and identify initial steps for their sustainability journey.

Said Mr Jeffrey Siow, Managing Director and Chief Operating Officer, Enterprise Singapore, "With growing attention on sustainable practices from governments, investors and consumers, our businesses must prepare for the inevitable transition to a green economy. Enterprise Singapore supports companies to integrate sustainable strategies and practices into their businesses through our Enterprise Sustainability Programme (ESP). As part of the ESP, we have developed this foundational playbook to guide SMEs on the first steps for their sustainability journeys."
- 5. Mr Kok Ping Soon, Chief Executive Officer, SBF said, "Sustainability is now a key imperative for companies, investors, consumers, and the government. Small and medium-sized enterprises (SMEs) that embed sustainability in their value proposition will be well-positioned to tap into green economy opportunities and future-proof their business. This playbook will help SMEs at varying stages of their sustainability journey to identify stage-appropriate resources, tools, and programmes and accelerate their adoption of environmental, social, and governance (ESG) practices. SBF will work closely with the business community to increase the adoption of solutions and tools for sustainability transformation and facilitate business access to sustainability market opportunities."
- 6. Said Mr Tan Kok Yam, Chief Executive, SkillsFuture Singapore, "Enterprises need new capabilities to do well in the green economy. These new capabilities, in turn, rely on employees acquiring new skills to take on changing job roles. This playbook provides a guide on upskilling the workforce, for the enterprise striving to go green. It also points to the training resources in place to support enterprises in their journey toward greater sustainability."

Annex: Sustainability support for businesses

Enterprise Sustainability Programme by Enterprise Singapore

Enterprise Singapore launched the Enterprise Sustainability Programme (ESP)³ in October 2021 to support Singapore enterprises to integrate sustainability into their business and capture new opportunities in the green economy. The ESP supports training courses, capability and product development projects, and key enablers in areas such as certification and financing. Under the ESP, EnterpriseSG will also be rolling out a series of sustainability playbooks, which include:

- Decarbonisation for Singapore Enterprises playbook, which was launched in January 2023⁴ by UN Global Compact Network Singapore, with support from EnterpriseSG and National Environment Agency.
- Sustainability Playbook for Enterprises: Embarking on your Environmental, Social and Governance (ESG) journey developed by EnterpriseSG, SBF and SSG.
- Other playbooks to address key topics and sectors such as sustainability reporting and logistics, which will be introduced subsequently.

Besides the playbooks, other recent initiatives under the ESP include:

- A new environmental disclosure programme by EnterpriseSG and CDP⁵ to provide a structured framework for Singapore enterprises disclosing their environmental data and performance.
- More foundational courses to help companies plug the knowledge gap and kickstart their sustainability journey, and new thematic courses on decarbonisation and sustainable finance.
- Extension of the enhanced support level of 70 percent under the Enterprise Development Grant to March 2026 for sustainability projects in areas such as strategy and product development, resource optimisation, and standards adoption.
- EnterpriseSG is also setting up a one-stop website to house resources and information on whole-of-government support measures to help SMEs get easier access to information and resources on sustainability.

Efforts by Singapore Business Federation

Singapore Business Federation (SBF) is driving industry awareness and adoption of ESG practices by shaping policies, building platforms, and forging the capabilities of our companies as they go about their transformation. SBF works closely with the business community through:

• Shaping policies: There are ongoing industry consultations and public-private dialogues to organise the industry response on sustainability-related policies and regulatory developments.

- Building platforms: SBF has completed several runs of the MAP transformation • programme⁶ on sustainability and is working with industry partners to plan more runs. SBF is also the appointed accreditation body for the Progressive Wage Mark⁷ which recognises firms that pay progressive wages to lower-wage workers.
- Forging capabilities: SBF runs the Career Conversion Programme for Sustainability • Professionals⁸ as well as a range of training programmes for companies looking to advance their ESG and social impact performance.
